

**TOWN OF BRIDGEWATER**  
**ALL-TERRAIN VEHICLE POLICY 2024**

The Selectboard of the Town of Bridgewater, County of Windsor, State of Vermont, hereby adopts the following policy:

Definitions:

1.) "All-Terrain Vehicles" or "ATV" means any non-highway recreational vehicle, except snowmobiles, when used for cross-country travel on trails or on any one of the following or a combination thereof; land, water, snow, ice, marsh, swampland and natural terrain. An "All-Terrain Vehicle" or "ATV" on a highway shall be considered a motor vehicle.

A.

All class 2 and class 3 Bridgewater Town Highways are CLOSED to ATV travel with the following exceptions:

**CHATEAUGUAY ROAD #5**

1. Open from the Merrikarto Bridge to the Barnard Chateaugay Road

**BARNARD CHATEAUGUAY ROAD #6**

1. The entire length of the Barnard Chateaugay Road #6 is open.

**STEVEN'S ROAD #21**

1. All of the Steven's Road #21 is open. (Bridgewater portion) RICHARDSON ROAD #22 1. All of the Richardson Road #22 is open. \*(Local Traffic Only) \*Amended June 11, 2024

**GOLDCOAST ROAD #26**

1. Goldcoast Road is open from the end of the blacktop to Kellogg Lot Road.

**LITTLE SHERBURNE ROAD #30**

1. All of Little Sherburne Road #30 is open. (Bridgewater portion)

**BLANCHARD ROAD #45**

1. All of the Blanchard Road #45 is open including the Fire Station Bridge. (Local traffic only)

**OXBOW ROAD #20**

1. All of the Oxbow Road #20 starting from the intersection of the Barnard Chateaugay Road #6 is open. (Bridgewater portion)

**HALE HOLLOW ROAD #44**

1. Hale Hollow Road #44 is open from the intersection of VT RT 100A to the Bridgewater/ Plymouth town line.

**RIVER ROAD #65**

1. River Road is open from the intersection of 100 A to the old Landfill site. (Added at Selectboard Meeting May 23, 2023)

B.

This policy shall terminate one (1) year from the date hereof unless sooner replaced by the adoption by the Town of Bridgewater of an ordinance for the regulation of ALL-TERRAIN VEHICLES pursuant to 24 V.S.A. Chapter 59.
